First, click on the "Participants" icon at the bottom of your screen. Next, click on the "Raise Your Hand" icon near the bottom right corner of the screen.
4. To raise your hand for telephone dial-in participants, press *9.
5. Members of the public may be muted or removed if using abusive language or if they become disruptive to the meeting.

Attendance to the meeting and participation during public comment periods will be conducted as follows:

- Members of the public must provide their name and address with their comments.
