

## **CITY OF MT. PLEASANT PARKING INFORMATION**



The City of Mt. Pleasant operates 12 parking lots in the downtown area containing a total of 675 parking spaces. Additional parking is available on the street. Each lot is clearly signed with the maximum permitted length of stay. All on-street parking is for three hours unless otherwise signed.

**Signed parking areas throughout the city are strictly enforced.**



### **DAYTIME PARKING PERMITS IN CITY PARKING LOTS**

Permits for parking from 8:00 a.m. to 5:00 p.m. in designated permit lots are available to downtown property owners, tenants and employees for \$37.50 per year. Others may purchase an annual permit for \$150. Permits are limited, and there is a waiting list. Call 779-5123, for further information.


**To avoid ticketing, permit must be displayed at all times.**



### **OVERNIGHT PARKING**

**Parking is prohibited from 4:00 - 6:00 a.m. in streets and lots in the area of the Central Business District identified in the map below. This is enforced year-round. The only exception is for those CBD residents who obtain an overnight parking permit.**

**On-street parking is prohibited in the remainder of the City from 2:00 to 5:00 a.m. from September 1 to May 1. Cars parked on snow routes during snow emergencies will be subject to ticketing and/or towing.**



Overnight parking is allowed in municipal parking lots only with a valid overnight parking permit and only in designated areas.

Overnight permits are available without charge to residents of the central business district. Guests of downtown residents must also obtain an overnight parking guest permit in order to avoid ticketing. Both permits are available at City Hall, Department of Building Safety.

Lots 1, 2, 4, 5 & 6 have designated areas for parking on odd and even days. Between 4:00 a.m. and 6:00 a.m., overnight permit holders must park in areas designated "even" on even days of the month (2<sup>nd</sup>, 4<sup>th</sup>, etc.). On odd days (1<sup>st</sup>, 3<sup>rd</sup>, etc.), vehicles must be parked in areas designated "odd". The even or odd day is determined between the hours of 4:00 a.m. and 6:00 a.m. Therefore, permit holders must park on the "odd" side if the date is "odd" during the early morning hours (4:00-6:00 a.m.) of the following day, and on the "even" side if the date is "even" during the early morning hours (4:00-6:00 a.m.) of the following day. Lot #3 works on the same odd/even principle; however hours of enforcement for Lot #3 are 2:00 - 5:00 a.m.

**Limited overnight parking is available in Lot 12 on the southwest corner of Broadway and Oak Streets.**
