SKATE PARK OPERATION DAWN TO DUSK. ABSOLUTELY NO USE IN DARKNESS OR DURING INCLEMENT WEATHER.
THE SKATE CENTER IS AN ALCOHOL, TOBACCO, AND DRUG FREE ZONE

MT. PLEASANT CITY PARK ORDINANCE 748 IS IN EFFECT AT SKATE PARK IN ADDITION TO THE FOLLOWING RULES:

USE THE RIGHT EQUIPMENT AND THINK SAFETY FIRST.

- NO STREET BIKES OR SCOOTERS.
- ONLY SKATEBOARDS, IN-LINE SKATES, FREESTYLE AND BMX BIKES IN PROPERLY FUNCTIONING CONDITION, ARE ALLOWED IN PARK.
- THOSE WITHOUT SKATEBOARDS, ROLLER BLADES, OR AUTHORIZED BIKES ARE NOT ALLOWED INSIDE FENCED AREA.
- NO STANDING, SITTING, OR HANGING OUT ON THE RAMPS.
- SPECTATORS ASSUME RISKS FOR THEMSELVES, AND MUST STAY OUTSIDE THE FENCED AREA.
- YOUTH 8 YEARS AND YOUNGER SHOULD NOT BE IN SKATE PARK UNLESS DIRECTLY SUPERVISED BY AN ADULT.
- PREFERENCE WILL BE GIVEN TO YOUTH 10 YEARS & YOUNGER BEFORE 10:00 A.M. NO ONE UNDER 10 SHOULD BE ON THE RAMPS AFTER 8:00 P.M.

BE COOL TO OTHER PARK USERS, SPECTATORS AND NEIGHBORS IN THE AREA.

- ROUGHHOUSING, HARASSMENT OR VIOLENCE ARE NOT PERMITTED.
- NO PROFANITY.
- NO SKATING ON ADJACENT PROPERTY.
- NO BOOM BOXES OR AMPLIFIED MUSIC.

HELP KEEP THE FACILITY SAFE, CLEAN AND THE RIDING SURFACE UNCLUTTERED FOR MAX ENJOYMENT!

- NO ANIMALS/PETS INSIDE SKATE AREA
- DON'T LITTER. PUT TRASH IN THE RECEPTACLES PROVIDED.
- DO NOT DRAW GRAFFITI, POST STICKERS OR ABUSE THE PARK IN ANY WAY.
- NO WAXING OF OBSTACLES
- NO PERSONAL RAMPS OR STREET ITEMS IN PARK.
- NO GLASS CONTAINERS ALLOWED IN ANY CITY PARK.
- NO FOOD, DRINK OR GUM INSIDE THE FENCED AREA.
