The City of Mt Pleasant has submitted a request to implement an Industrial Pretreatment Program, pursuant to R323.2307 of the Michigan Administrative Code. The Michigan Department of Environment, Great Lakes & Energy has reviewed the City's request and finds that the submission meets the requirements of R323.2306 of the Michigan Administrative Code.

The proposed Industrial Pretreatment Program (IPP) provides the necessary framework to control non-domestic contributions to the Mt Pleasant sanitary sewer system and Water Resource Recovery Facility.

TAKE NOTICE THAT THE CITY COMMISSION WILL MEET VIRTUALLY ON MONDAY, SEPTEMBER 27, 2021 AT 7:00 p.m. AS PART OF THEIR REGULARLY SCHEDULED MEETING TO RECEIVE PUBLIC COMMENT ON THE INDUSTRIAL PRETREATMENT PROGRAM WHICH INCLUDES AMENDMENTS TO CHAPTER 51: SEWERS of the Mt. Pleasant City Code.

Comments or objections to approval of the Industrial Pretreatment Program which are received within 30 days will be considered in the final decision to approve the IPP. If no substantive comments are received, no further public notice will occur.

The request for a hearing should: list the reasons why a hearing is being requested; identify the relevant issues; and identify specifically which portions of the proposed IPP are of concern. Copies of the submittal and justifying documentation may be reviewed at the Bay City District Office.
